- I accept for use as is the equipment listed on this form and also accept full responsibility for the care of the equipment while it is in my possession.
- I agree to reimburse Fastski Sports for any damage of any kind, other than reasonable wear, which results from the use of this equipment.
- I accept responsibility for replacement at full retail value of damaged / stolen equipment. I will be responsible for any and all equipment rented under this agreement. The rented equipment is to be used for normal recreational skiing / snowboarding only, at the ski area. I agree to return all rented equipment by the agreed date, boots must be clean, in a dry condition to avoid any additional charges. If the equipment is not returned by **9:00 a.m.** of the day due in, an additional day will be charged. **(Please Initial _____)**.
- I understand and am aware that skiing / snowboarding is a **HAZARDOUS** activity. I understand that the sport of skiing / snowboarding and the use of the ski / snowboard equipment involves a risk of injury to any and all parts of this user's body. I hereby agree to freely and expressly assume and accept any and all risks of injury to the user of this equipment while skiing / snowboarding. **(Please Initial _____)**.
- I understand that the ski / snowboard equipment being furnished forms a part of or all of a ski-board-boot-binding system which will **NOT RELEASE** at all times or under all circumstances, and that it is not possible to predict every situation in which it will or will not release, and that its use cannot guarantee this user's safety or freedom from injury while skiing / snowboarding.
- I further agree and understand that this ski-board-boot-binding system may reduce but does **NOT ELIMINATE THE RISK** of injuries to any portion of this user's legs or body. However, I agree and understand that this ski-board-boot-binding system may **NOT** reduce the risk of injuries or damages to the user of the equipment listed on this form or to any other person. I agree **NOT** to make a claim against or sue this ski shop for injuries or damages relating to skiing / boarding and / or the use of this equipment. **(Please Initial _____)**.
- I hereby agree to accept the terms and conditions of this contract. This document constitutes the final and entire agreement between this ski shop and the undersigned. This ski shop, itself, provides **NO WARRANTIES**, express or implied, and this ski / board equipment is accepted for use "as is".
- I have carefully read this agreement and release of liability and fully understand its contents. I am aware that this is a release of liability and a contract between myself and this ski shop and I sign it of my own free will.
- I agree that I understand how the ski-board-boot-binding system works, and I will be instructed in its proper use. I agree that the binding release / retention setting numbers appearing in the visual indicator windows on the binding correspond to the binding release / retention settings recorded on this form. I agree to check this ski / board equipment before each use, including the pad (AFD) anti-friction device, under my boot sole, and that I will not ski / board if any parts are worn, damaged or missing.
